Notes to the Enrolment Eligibility Claims Form

1 When to use this form	The Corporate Body may make a claim to register nominees using this form at any time. However, if the Corporate Body wants to be represented on the roll for a particular election it must give its claim form to the Shire of Moora more than 50 days before the election date
2 Who should use this form	 You should fill in this form if you: own or occupy³ rateable property in a district but are not on the residents roll in that district; or qualify under clause 12 of Schedule 9.3 to the <i>Local Government Act 1995</i> ⁷, and want to be able to vote at Shire of Moora elections.
3 Who is an occupier	To qualify as an occupier the Corporate Body must have a right, under a lease, tenancy agreement or other legal instrument, to be in continuous occupation of the property for at least the next 3 months.
	Proof of your right of occupation may be requested.
4 Silent address	If having your address on the register or on the roll would put your safety, or that of your family, at risk you may ask the Chief Executive Office not to show your address on the register or on the roll. To do this you must give to the Chief Executive Officer a statutory declaration setting out the reasons why you do not want your address shown on the roll.
5 Rateable property	If you own or occupy more than one property in the electorate give details of them all. Add additional pages if necessary.

7 Qualification under clause 12	 To qualify under clause 12 of Schedule 9.3 to the <i>Local Government Act</i> 1995 you must: own or occupy rateable property in the electorate; have been on the last electoral roll prepared under the <i>Local Government Act 1960</i> for that electorate; and have owned or occupied rateable property in the electorate continuously since that roll was prepared.
8 Nominations	In relation to the rateable property on which the enrolment eligibility claim is based, this relates only to the portion of the property that the Corporate Body owns or leases. A nomination by a Corporate Body must be made in writing and be signed by an officer of the corporate body in accordance with the Local Government (Elections) Regulations 1997. If a corporate body or group of people owns or occupies more than one property in the Shire of Moora, a nomination applies to all of those properties.
9 Duration of enrolment	If the Corporate Body's enrolment of occupier's eligibility claim is accepted it will remain valid for the next 2 (or in limited circumstances, next 3) ordinary elections held for the Shire of Moora, if the nominees have enrolled as non-resident occupiers. If the Corporate Body is an occupier and you wish the nominees to continue to qualify as electors after that, the Corporate Body will need to make another Application to Register a Corporate Nominee. For non-resident owners, the claim will remain valid until you cease to own the rateable property on which the claim is based.
10 Confidentiality	Your date of birth, phone and fax numbers and email address supplied in this form will be kept confidential and will be used only by the Shire of Moora and the Western Australian Electoral Commission for the purpose of preparing local government electoral rolls.
11 Where to send your form	When you have completed and signed this form, send it to the Chief Executive Officer of the Shire of Moora, PO Box 211, MOORA, WA 6510. You may send it by post, by fax or by other electronic means so long as it is capable of being printed in its entirety, including a signature. If you send it by fax or electronically you should check that it has been received.
12 Change of Address/Details	If you are currently enrolled as an elector for the Shire of Moora and you wish to advise of a change of address or any other enrolment details, please do not complete this form. Simply advise the Shire of Moora in writing of the amended details to your enrolment.
